

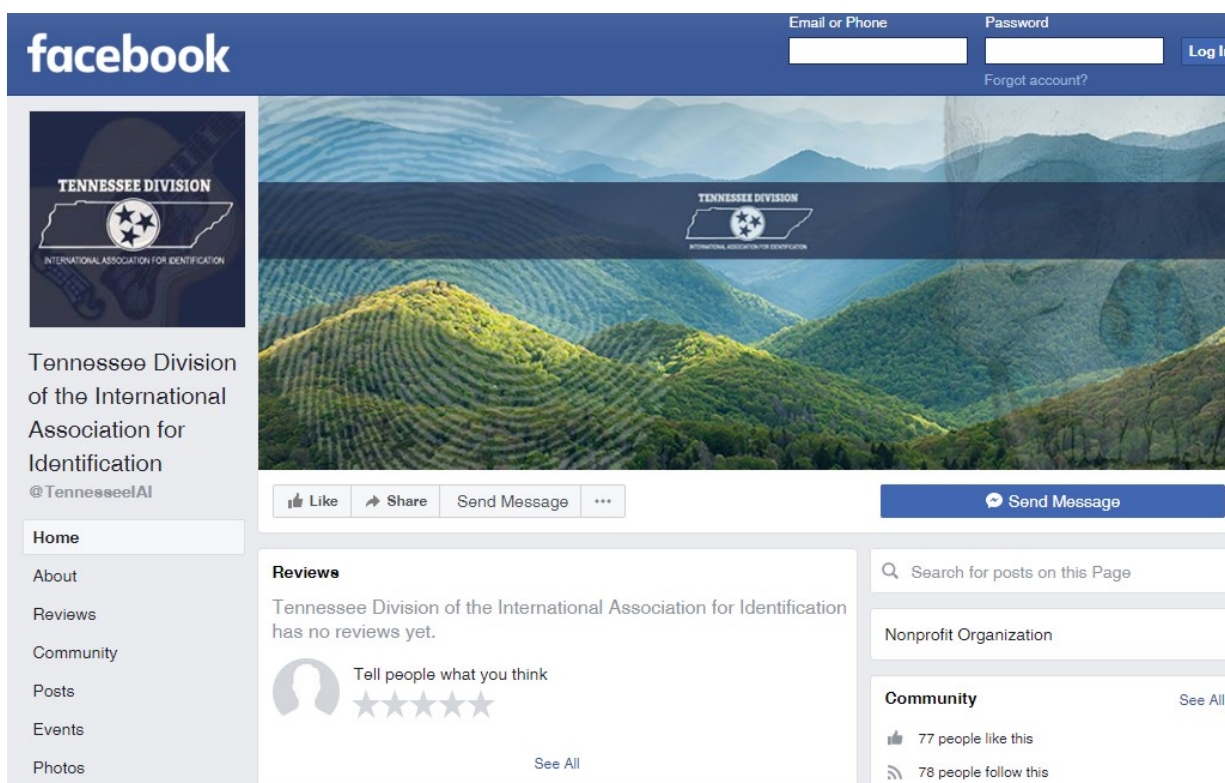

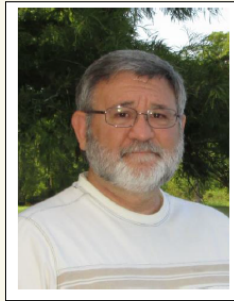

He is certified by the International Association of Identification as a Latent Print Examiner and Footwear Examiner, past Board of Director member and is still active with the IAI. Dwane has been invited to speak on various subjects across the United States and abroad, which is one of the results of his "involve them and they will learn" teaching style that has made him well-known in the criminal justice profession. 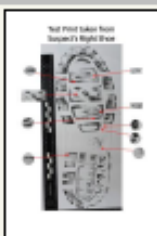
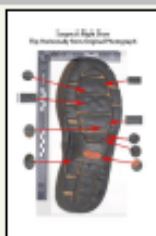
Examination and Comparison of
Footwear Impression Evidence

Chattanooga Police Department, Chattanooga, TN
Course Dates: August 13-17, 2018

COURSE DESCRIPTION:

This training course is designed to present a series of interactive lectures using PowerPoint, Adobe Photoshop, and various other software programs. This training course will provide an overview with both lecture and hands-on exercises of the proper methods and techniques in the examination and comparison of footwear evidence. There will be various discussions related to the proper techniques and methodologies in the examination and comparison process. There will be heavy discussions on the manufacturing of outsoles and how it pertains to the comparison process. Numerous practical exercises both in class and outside of the classroom are utilized and implemented to emphasize and critique the skills of the students to properly perform this level of training in footwear science. After each exercise the student's work will be critiqued and measured.

This training class has been approved by the International Association for Identification as credit towards certification or re-certifications



COURSE TOPICS:

- *Brief History of Footwear and the Evolution of Footwear Production.
- *Anatomy and Bones of the feet and Nomenclature of Shoes
- *Evidentiary Value of Symbols and Logos in Footwear
- *Terminology of Shoes and Manufacturing Processes and Outsole Construction Methods
- *Descriptive Methods of the Types of Characteristics in the Comparison Process and Exemplar Preparation
- *Proper Documentation, Collection and Preservation of Footwear Evidence
- *ACE-V Methodology and OSAC Guidelines
- *Elements of Report Writing
- *Legal Considerations and Courtroom Testimony

WHAT TO BRING TO THE COURSE:

Casual attire is suitable. Laptop with Adobe Photoshop is recommended but not necessary. All other supplies will be provided.

WHO SHOULD ATTEND?

This course is designed for criminal evidence analysts and forensic scientists with the responsibility for examining and comparing footwear impression evidence. This is a beginning basic course required for those wishing to begin a career in footwear impression evidence.
